## CASE STUDY: STRATEGIC PLANNING & FACILITATION SUPPORT FOR A REGIONAL PLANNING GRANT

In November 2018, with funding from the federal Health Resources and Services Administration (HRSA), a regional consortium formed to develop a **comprehensive strategic plan** to address substance use in the three “far west” counties of North Carolina—Cherokee, Clay, and Graham Counties. The consortium includes regional substance use treatment providers, a federally qualified health center, three county health departments, and other regional partners.



WNC Health Network helped consortium members decide how they wanted to work together and clarify the overall result they have in mind for their work in the region. We helped **design and collect data for an in-depth needs assessment** to understand the “story behind the numbers” around substance use in the region. This involved creating a data “workbook” of substance use indicators from our large primary dataset and other data sources, as well as gathering information from people most affected by substance use and key informants.

We then worked with the consortium to design a **multi-step strategic planning process** and led a series of meetings with them to use findings from the needs assessment to develop the plan. As a result of their commitment to excellence in the “how,” the consortium developed a **strong plan rooted in local needs and context** and has secured an additional \$1M of federal funding to carry out the plan over the next three years.
